- 1. Introduction
  - 1.1 President of SIET, Dr. Balaji Sadasivan assumed the Chair and proceeded to conduct the meeting after confirming with the General Secretary that there was a quorum.
  - 1.2 In his opening he touched on the importance of education and emphasized that education was fundamental for the well being and success of the community.
  - 1.3 He also commended previous generation of leaders in the 60's and 70's for having the vision to realize the importance of education for the community and helping to form and build up an organisation like SIET.
  - 1.4 Dr. Balaji also paid tribute to his predecessor Mr. S Chandra Das for having provided strong and stable leadership at SIET over the past 25 years.
  - 1.5 He praised SIET for its efforts in providing monetary aid through bursary awards, achievement awards and local and overseas study loans as well as providing guidance to Indian youth through channels like its ConneXus Mentorship Programme.
  - 1.6 Dr. Balaji noted SIET's partnerships with other community based organisations such as SINDA, PA Narpani Pearavai as well as the Singapore Indian Chamber of Commerce and highlighted the recent joint event on Entrepreneurship as an example of such partnerships.
  - 1.7 He mentioned that as a part of the renewal process, three Council Members had voluntarily stepped down and others have stepped forward to fill the positions in the Management Council.
  - 1.8 It was noted that Mr. Ramesh Selvaraj, Ms. Shanthini Muthiah and Mr. Raveen Tilani have stepped down from the Management Council. The Treasurer Mr. S Malaiappan has stepped down as required under the constitution of the Trust.

- 1.9 Dr. Balaji thanked all outgoing Council members on behalf of SIET for their contributions and wished them all the best in their future endeavours.
- 1.10 Dr. Balaji also alerted members present about the looming global recession and advised that people must accept that economies undergo cyclical changes and learn to cope with the ups and downs.
- 1.11 He noted that the downturn would be a challenging period for community organisations like SIET in terms of raising funds and added that SIET should work closely with other community organisations to overcome the setbacks.
- 2. To confirm and approve the Minutes of the 38th Annual General Meeting held on 19th May 2007 (appearing in pages 3 6 of the annual report, 2007).

The Secretary confirmed that no notice of amendments was received and the minutes were adopted by members present as:

#### 3. To consider matters arising.

There were no matters arising from the previous AGM Minutes.

- 4. To receive and adopt the Annual Report of the Management Council for the period ending 31st December 2007.
  - 4.1 Referring to the number of members, Mr. R Asokan spoke of the need to increase the number of ordinary members.
  - 4.2 Mr. N P Karthigayan proposed a "member get member" program to be introduced.
  - 4.3 Mr. P Raveentheran suggested that SIET adopt a system to encourage loan and award recipients to contribute back to SIET.
  - 4.4 Mr. Bala Subramanion proposed that a new column be added to the membership records shown in the Annual Report to reflect the number of new members who have joined during the year. He also said that while SIET must be commended for being able to raise funds, it must continue to focus on increasing its membership base.
  - 4.5 Dr. Balaji agreed that the points raised about membership were valid and that more can be done to increase the membership base.
  - 4.6 Mr. N P Karthigayan referred to Page 57 showing outstanding amount of S\$ 3,850 from a loan granted to Mr. Muthukumaran s/o Vetrivelu in 1997. Mr. Karthigayan asked what steps have been taken to recover the loan.

Mr. V P Jothi responded that every effort has been taken to recover the loan including legal letters to the last known address. Despite the efforts Mr. Muthukumaran was not contactable. Instead of writing off the loan as bad debt the outstanding amount remains on record with the hope the money will be recovered one day.

- 4.7 To a question on whether interest was charged on outstanding loans, Mr. V P Jothi replied that on loans outstanding after the 5 year repayment timeline, interest will be levied and that this condition was introduced 2 years ago.

### The Chairman's Message



I am pleased to report that the Trust has continued to provide financial assistance to needy students in the Indian community through various bursary and study loan programs over the past year. We have at the same time expanded our role through the provision of mentoring programs for students and at the same time challenging students who are doing well to strive to excel in their respective fields through the provision of achievement awards and special awards.

#### Our key efforts have been in the following three areas:

#### Additional Financial Support to Needy Singaporeans

• In times of economic difficulties bursaries were given twice in 2008 with a record sum of \$204,200 being distributed to needy students.

• We have also embarked on a program where we have individualized meetings with bursary applicants and their parents if they have not done well in their exams to motivate them to take advantage of the various support mechanisms available to help them improve their academic performance.

#### Building a Culture of Active Community Participation Through ConneXus

• We have embarked on expanding our mentor pool for ConneXus so that we can encourage more professionals who are doing well to serve and reach out to motivate and guide more students. • Our mentoring efforts through ConneXus are also being supported through our active partnership with organizations like the Singapore Indian Chamber of Commerce.

#### Challenging Indian Students to Excel

We continue to motivate ITE students who are doing well to sustain their efforts and encourage their course-mates to do the same through meeting up with good students and providing deserving students Achievement Awards. A record number of 21 ITE students were given Achievement Awards in 2008.
35 other students from the University, Polytechnics and Junior Colleges were similarly recognized.

• We have also continued to provide awards to encourage talented Indian students to excel in the areas of sports and the arts. We have for the first time also given a special recognition award to recognize Jathishweran Naidu for his outstanding performance in the movie "My Magic' which was nominated and screened at the Cannes Film Festival.

Looking ahead, we need to continue to seek ways to raise funds to support Indian students. This is becoming even more critical as we face economic uncertainties with more families likely to be in need. Many have stepped forward to contribute in the past and on behalf of the Trust, I would like to urge all members to rally more financial support for this very worthy cause.

The accounting function of the Trust continues to be outsourced and has been provided by Mr. V R Ranganathan of Mohan and Associates since January 2007.

#### 5 Bursaries

The Trust disbursed bursaries twice in 2008:

- The 7th Indian Community Bursary Award (ICBA) presentation was held on 1st March 2008 where SIET provided bursaries worth **\$\$85,300** to 343 Primary and Secondary school students.
- The 8th ICBA presentation was held on 13th December 2008. 428 primary and secondary students received bursary awards worth **\$107,600** from SIET.
- The Trust also gave bursaries worth **\$\$6,500** to 13 needy and deserving students from ITE, Polytechnic and JC and a further **\$\$4,800** to 16 students at Northlight school.
- The Central Sikh Gurdwara Board's donation of **\$\$10,000** is maintained by the Trust to benefit Sikh students who qualify for bursary awards. The principal amount is topped up annually after disbursements have been made. For 2008, the Trust awarded 21 students a total of **\$\$5,200**.

#### 6 Awards and Study loans

The Trust continues to identify deserving students for the various awards and study loan schemes which are being administered. In keeping with our goal to encourage Indian students to pursue areas they are talented in, the Trust has also provides awards for deserving students in the field of Sports and the Arts. SIET Achievement Awards for JC, ITE, Polytechnic and University Students

A total of **56** awards worth **\$\$78,500** were given at the 4<sup>th</sup> SIET Achievement Award ceremony on 1<sup>st</sup> November 2008 by Guest of Honour, Ms. Indranee Rajah, Deputy Speaker and Member of Parliament, Tanjong Pagar GRC. Eighteen awards went to University students, nine awards to Polytechnic students, eight to Junior College students and twenty one to ITE students. These awards recognize the all round performance of students and award recipients are encouraged to continue to excel while at the same time contribute to the community.

#### SIET Special Recognition Award

A Special Recognition Award of **S\$1,000** was given to Jathishweran Naidu s/o Gopalan Naidu for his outstanding performance in the movie "My Magic" directed by Mr. Eric Khoo. The movie was nominated and screened at Cannes Film Festival. The Award was presented by the President of SIET, Dr. Balaji Sadasivan.

#### **Conference Awards**

A total of **\$\$3,500** was extended to two students to allow them the opportunity to present papers at international conferences.

#### SIET – Sports and Arts Awards

A total of eight study awards totaling **S\$ 24,718** was extended to talented students from the Singapore Sports School and the School of the Arts in 2008.

#### **SIET Study Loans**

Study loans totaling **\$\$51,589.95** were awarded to six undergraduate students to support them in their studies.

#### G Sarangapany Fellowships in Media

Fellowships worth **\$\$5,000** each were awarded to two students pursuing their Masters in Mass Communication at NTU.

# SIET Global Immersion Programme (GIP) Scholarship at Nanyang Technological University

Two awards worth **\$\$5,000** each was given by SIET for the first time to students studying at NTU under the GIP scheme which allows students to benefit from an attachment programme in a foreign country.

#### NUS Tamil Language Society Tuition Programme (Saadhana)

Saadhana aims to enhance the performance of 'A' level Indian students by providing quality tuition at heavily subsidized rates. Saadhana 2008 was held in Yio Chu Kang Secondary School from May to October. **97** students benefitted from the program.

SIET continues to be a major provider of financial support for Saadhana and shares the NUSTLS's aim of ensuring that a greater number of Indian students excel in their A levels and qualify to enter Universities. Funding for this programme was **S\$10,000**.

#### 8 Investments

SIET's Investments portfolio was not drastically affected by the ongoing global financial crisis. SIET's investments fared significantly better than marketaverages. The investment committee of SIET is fully committed to preserving the value of its assets by following a prudent low risk investment policy.

The portfolio continues to reflect a mix of investment grade fixed income securities and active use of cash via fixed deposits and preferred securities of local banks. Approximately S\$2 million in fixed income securities has allowed SIET to earn approximately **S\$60,000** in 2008 as current income.

The Committee is confident that the strategy of investing in relatively high yield fixed income securities with an avoidance of equities continues to be the right strategy for SIET. This strategy has allowed it to earn a current income of approximately 5% per annum with a principal protection and a strategy which avoids huge mark to market losses.

#### 9 Endowment Funds and Donations

The Trust received the following contributions towards the Endowment Funds:

- 1. PA Narpani Pearavai Education Trust Fund **\$\$20,700**
- 2. Galaxy Education Trust Fund **S\$4,994**

The Trust also received a significant donation of **\$\$50,000** from the Republic of Singapore Yacht Club from the proceeds of a Charity Golf Tournament.

#### 10 Conclusion

We have significantly increased our financial support to the Indian community in 2008 through our various schemes. Many have stepped forward to support the cause of the Trust and we are confident that even in times of economic uncertainty, we will continue to receive the support of the very many individuals and organizations that have been steadfast in their support of the Trust.







#### eMentoring

Mentorship in areas such as Medicine, Law, IT and Entrepreneurship has been active this year.

As a part of the mentorship program for medicine, a second hospital attachment was organized by Dr. S Ramesh for 6 students from various Junior Colleges and the Singapore Polytechnic. The students who were interested in the medical field were provided with an invaluable opportunity to gain an insight into the medical profession through a 5 day attachment at Changi General Hospital Orthopedic Unit, Flinders Practice, NUH Ophthalmology Unit, Singapore General Hospital Neurosurgery Unit, Singapore Medical Centre, and Tan Tock Seng Hospital.

The mentees have actively used the forum board to interact and to plan for their attachment and post feedback about their daily experiences. Mentors have found the forum board a time-saving tool to post logistical details about the attachment.

We want to attract more ITE and Polytechnic students onto this new platform. To further this objective a road show is being planned for 2009 jointly with the Singapore Indian Chamber of Commerce.

### **Reflections of our Award Recipients**






